## List of shortcoming/deficiencies point out by the Inspection Committee, Dean of Colleges in respect to CDL College of Ayurveda, Jagadhri

1. Some previous visit observation/shortcomings didn't complied which is as under:
  - a. Higher Teaching Faculty (Professor/Associate Profession) is not available in the Deptt. of Swasthavritta and yoga.
  - b. The University Nominee was not included in the recruitment process of the Faculty and same observation was made by previous committee.
  - c. Some faculties are not registered with state board.
  - d. AGBAS Biometrics with CCTV Camera & status (Teaching, Non-Teaching, Hospital Staff and Interns) is not available.
2. Higher Teaching faculty (professor/associate) is not available in the department of Swasthavritta and Yoga and Agad Tantra. In the Deptt of Agad Tantra there is only 1 assistant professor availbale. These vacant posts should be filled at earliest before commencement of new session.
3. Separate toilet facility was not available in every IPD ward so provision of this facility should be made at earliest.
4. Adequate space is available in departments but provisions for separate sitting compartments should be made available for faculty members in each department.
5. the University nominee was not included in the recruitment process of faculty and same observation was made by previous committee.
6. Some faculties are not registered with Haryana state board of ISM registration.
7. AGBAS biometrics with CCTV camera & status of (Teaching, Non-teaching, and Hospital Staff) is not available and same observation was made by previous committee.
