 The request of the college is accepted and the college may be asked to submit the copy of resolution of society regarding reduction of intake for B.Ed. course.

And Whereas, accordingly letter was issued on 02.09.2020 to the institution.

And Whereas, the institution has submitted reply in the NRC office on 04.06.2020 on the basis of minutes and 14.09.2020.

And Whereas, the matter was considered by NRC in its 317 (Virtual) Meeting held on 22rd to 23rd September, 2020 The Committee decided as under:-

The application of the institution for permission to reduce intake of 150 (03 Units) out of existing intake of 300 (06 Units) in B.Ed. course from the academic session 2020-21 is accepted by the NRC. A letter to this effect be issued to the institution and affiliating body accordingly.
