**ORDER**

WHEREAS, recognition was granted to the institution namely, "Ch. Devi Lal College of Education, Bhagwan Parshuram Education Centre, Ambala Road, Jagadhri- 135003, Haryana vide Order No. F.NRC/ NCTE/F-3/HR-161 dated 08<sup>th</sup> July, 2004. Intake 100, B.Ed. (Addl.) Intake course of 100+100=200 (Two Hundred Only) students vide NRC order No. NRC/ NCTE/F-7/HR-494/2007/94181 dated 29.09.2007 and B.Ed. Addl. Course an annual intake of 100+ Additional 100=200 (Two Hundred Only) students vide NRC order No. F.NRC/ NCTE/HR-1136/2008/60015 dated 03.09.2008 and Corrigendum was issued on 10.09.2018 for B.Ed. course an annual intake of 200+ additional 100 = 300 (Three hundred only).

In light of the above, the Northern Regional Committee, NCTE hereby issue the Revised Recognition Order No. NRC/NCTE /NRCAPP/HR-161+HR-494+1136+2015/105501-05 dt. 27.05.2015 for B.Ed. course for annual intake of 300 students.

And Whereas, the institution submitted representation dt. 05.08.2019 received in NRC office on 06.08.2019 requesting to reduce its intake from 300 (Six Units) to 150 (Three Units) students.

And Whereas, the matter was considered by NRC in its 313<sup>th</sup> Meeting (Part-2) held on 25<sup>th</sup> to 27<sup>th</sup> February, 2020 and the Committee decided as under:-

1. The request of the college is accepted and the college may be asked to submit the copy of resolution of society regarding reduction of intake for B.Ed. course.

And Whereas, accordingly letter was issued on 02.09.2020 to the institution.

And Whereas, the institution has submitted reply in the NRC office on 04.06.2020 on the basis of minutes and 14.09.2020.

And Whereas, the matter was considered by NRC in its 317 (Virtual) Meeting held on 22<sup>nd</sup> to 23<sup>rd</sup> September, 2020 The Committee decided as under :-

The application of the institution for permission to reduce intake of 150 (03 Units) out of existing intake of 300 (06 Units) in B.Ed. course from the academic session 2020-21 is accepted by the NRC. A letter to this effect be issued to the institution and affiliating body accordingly.
